

## **SUMMARY ANNUAL REPORT FOR MISSION SUPPORT ALLIANCE LLC HEALTH AND WELFARE BENEFIT PLAN**

This is a summary of the annual report of the Mission Support Alliance LLC Health and Welfare Benefit Plan, a health, life insurance, dental, temporary disability, long-term disability and death benefits plan (Employer Identification Number 30-0419594, Plan Number 501), for the plan year 01/01/2020 through 12/31/2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **Insurance Information**

The plan has insurance contracts with Life Insurance Company Of North America, Kaiser Foundation Health Plan Of Washington, Kaiser Foundation Health Plan Of Washington Options, Inc., and Delta Dental Of Washington to pay certain Accidental Death and Dismemberment, Business Travel Accident, Life insurance, Long-term disability, Temporary disability, Health (HMO, PPO), Vision, Prescription drug and Dental claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2020 were \$11,244,587.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2020, the premiums paid under such "experience-rated" contracts were \$645,176 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$560,040.
